"Save the Vote" - What?

 "No person with a disability can be excluded from the right to vote or to stand for election on the basis of her/his physical and/or mental disability unless the deprivation of the right to vote and to be elected is imposed by an individual decision of a court of law because of proven mental disability."

"Save the Vote" – Why? Int'l HR Framework

- CRPD Article 12(2): "persons with disabilities enjoy legal capacity on an equal basis with others in all aspects of life"
- CRPD 29(a): "ensure that persons with disabilities can effectively and fully participate in political and public life on an equal basis with others, directly or through freely chosen representatives, including the right and opportunity for persons with disabilities to vote and be elected"



"Save the Vote" – Why? Paradigm Shift

FROM	\rightarrow	ТО
Disability is an individual problem	\rightarrow	Disability is a problem in society
Differences in abilities are inadequacies	\rightarrow	Differences in abilities are assets
Seeing deficits	\rightarrow	Seeing strengths
Us and them: exclusion - tolerance	\rightarrow	All of us: inclusion - valuing
Society choosing for 'them'	\rightarrow	Disabled people choosing for themselves
Professionals know best	\rightarrow	People have different kinds of knowledge
Charity based	\rightarrow	Rights based
Patient	\rightarrow	Citizen
Institutional orientated	\rightarrow	Community orientated
Medical model of disability - control or cure	\rightarrow	Social model of disability - change environment and attitudes
