UN Convention on the Rights of persons with disabilities

- Signed by the Republic of Moldova on March 30, 2007
- Ratified by the Parliament on July 9, 2010

Current situation

- Persons with disabilities: 183.415 (about 5,2% of the population)*
- About 46 % of public buildings comply with accessibility conditions
- About 15 % of the polling stations' premises comply with accessibility conditions

* 01.01.2014

Three voting procedures:

- ordinary voting
- assisted voting
- voting at the place of stay with the mobile voting box



Legislative safeguards*

- the right to adequate, accessible and easily understood and used voting procedures and materials (implementation of alternative voting modalities)
- the right to free opinion about political parties and their candidates, including by organization of electoral debates and radio/TV shows in mimic-gesture language, printing out electoral materials using the writing systems used by the persons with visual deficiency, and by using other information tools accessible for persons with disabilities

Achievements in the area of accessibility to the electoral process

- Adopting the Instruction on ensuring the PS's infrastructure (12 August 2014)

- Adopting the Regulation on the electoral campaign media coverage (17 April 2015)

- Adopting the Declaration on the accessibility of the electoral process for disabled persons (21 April 2015)

Area of visual disabilities (1)

Extending testing the voting procedure using the template-envelope for the voters with visual disabilities *

Shooting the didacticmethodological movie "Direct and secret voting of persons with visual disabilities using the templateenvelope"**

* 2010 – 1 polling station (PS) 2014 – 57 PS's 2015 – 100% PS's





Area of visual disabilities (2)

- Printing the Voter's Guide in Braille language
- Developing the audio version of the Voter's Guide
- Developing the audio motivational spots in Romanian and Russian languages
- > Special rulers for the voter to apply the signature in the voters' list
- Voting booths equipped with additional light sources and magnifiers

Adjustment of the secret voting booths to special needs
(size 50 cm*30cm*150cm)

> Equipping the polling stations with special ramps






Area of mobile disabilities (3)

➤ Accreditation of 31 national observers from the "Motivation" Association, of whom 16 are persons with mobile disabilities

- Involving 2 persons with hearing disabilities as observers in the parliamentary elections from 2014
