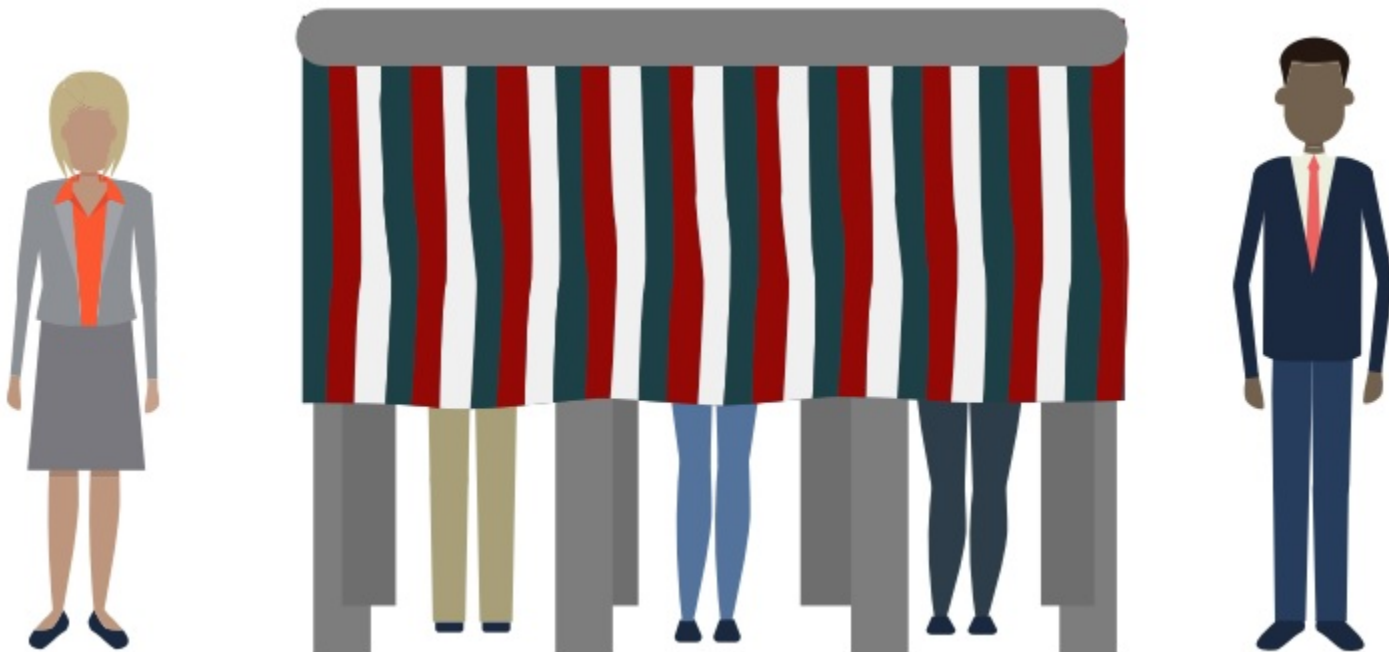

About the EAC

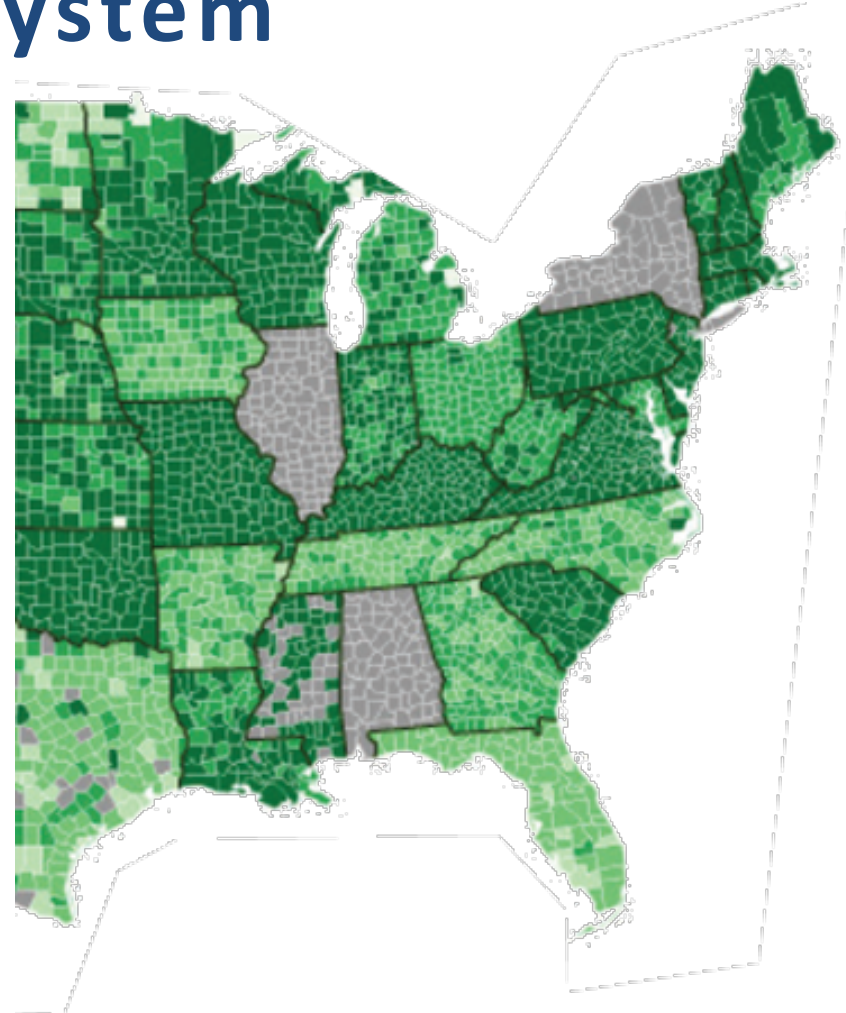


- Distributes, administers and audits the use of HAVA funds – Security, COVID
- Adopts voluntary voting system guidelines, certify voting systems and accredit testing laboratories
- Develop guidance to meet HAVA requirements
- Serve as a national clearinghouse of information on election administration
- Maintains the National Mail Voter Registration Form



The American Election Administration System

- Decentralized
 - States and local jurisdictions run elections - There are more than 50 election administration systems
- Non-uniform
 - Election administration systems vary from jurisdiction to jurisdiction and from state to state.
- Thousands of jurisdictions
 - Over 8,000 jurisdictions





Federal Election Agencies



U.S. Election Assistance Commission – resource for election officials

- Bipartisan Commission established by the Help America Vote Act (HAVA)
- Independent federal agency



Federal Election Commission – regulator of election activity

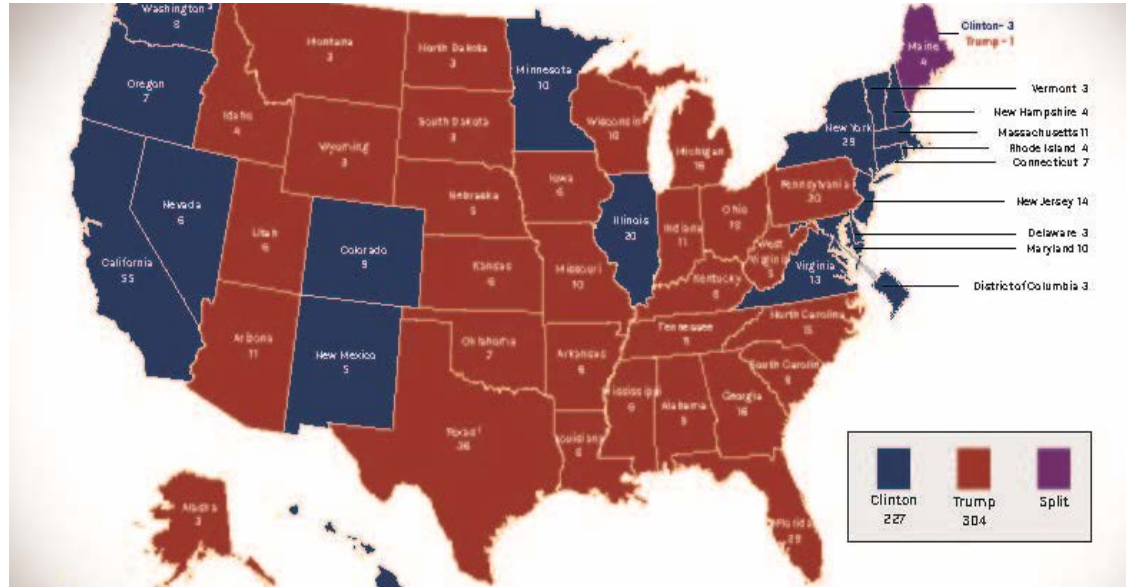
- Candidate behavior

DHS CISA, FVAP, DOJ, Census Bureau, Postal Service

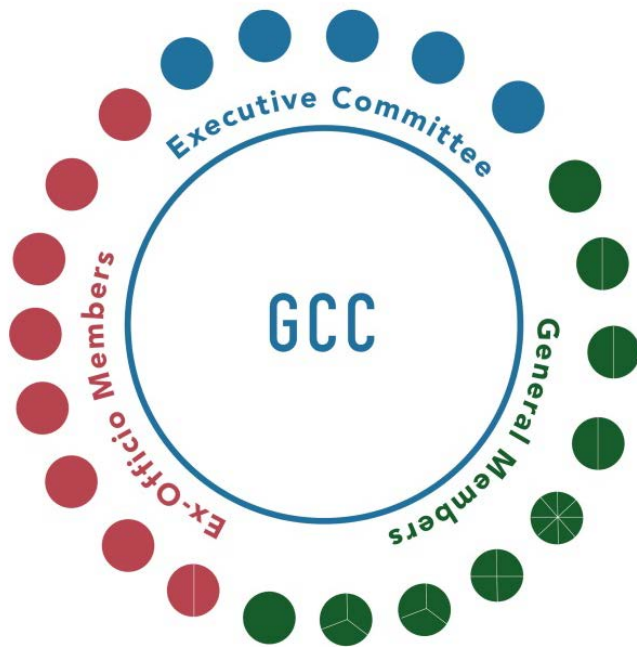


2016 Election Overview



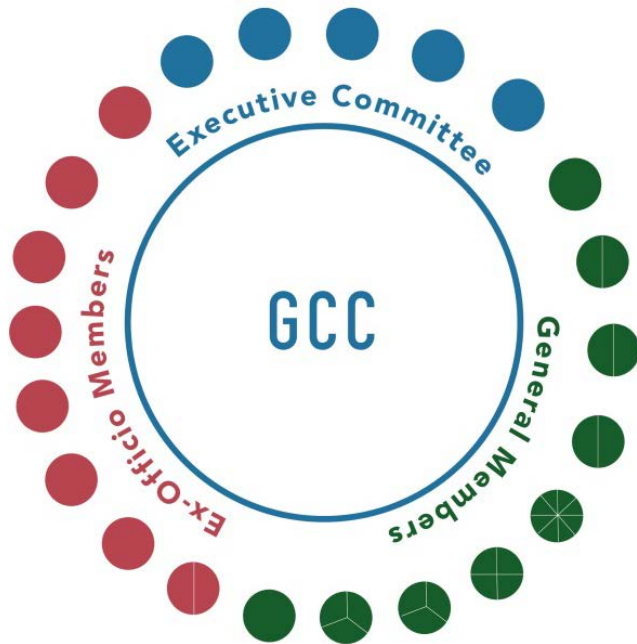
	Popular vote	Electoral Votes (270)

Critical Infrastructure



- January 2017, DHS designated U.S. election systems as part of the nation’s critical infrastructure
- Designation given to “systems and assets, whether physical or virtual, so vital to the United States that the incapacity or destruction of such systems and assets would have a debilitating impact on security, national economic security, national public health or safety, or any combination of those matters”

GCC and SCC



- Government Coordinating Council (GCC)
 - enables interagency and intergovernmental coordination
 - comprises representatives across various levels of government (Federal and State, local, tribal and territorial)
 - EAC plays a leading role
- Sector Coordinating Council (SCC)
 - private sector manufacturer counterpart to the GCC



Elections Infrastructure

GCC/SCC Joint COVID Working Group

- Documents provide guidance for state, local, tribal, and territorial election officials on how to administer and secure election infrastructure in light of the COVID-19 epidemic
- All products were developed in coordination with election officials, non-profits, and the private sector, and were approved by the executive committees of the GCC and SCC.
