# Training in Bosnia and Herzegovina – Legal Grounds

BiH Election Law sets forth the following:

- **mandatory continuous education** of election administration;
- **sanctions** – relieving members of election commissions and polling station committees of duty when they fail to attend mandatory training sessions;
- **enacting annual education plan and program** for EMB members;

# Training in Bosnia and Herzegovina

General objective of education of electoral stakeholders:

- to familiarize electoral stakeholders through seminars, roundtable discussions and other events with laws and by-laws relating to organization and conduct of the elections, with their obligations after the elections;
- building capacity of the electoral stakeholders to efficiently manage and conduct elections in line with the law.

# Training in Bosnia and Herzegovina – Voter Education

BiH Election Law sets forth the obligation of the CEC:

- to conduct voter education in country and abroad (out-of-country voting)

# Training of Election Administration General Elections 2014

In line with Plan and program of education of election management bodies for 2014 election year, the following activities were successfully conducted:

- Training of Voter Registration Center staff
- Regional trainings on election regulations
- Trainings of polling station committees
- Training of presidents and members of the polling station committees
- Training of polling station committee members at BiH Embassies
- Country-wide election test run (dry-run) week before E-day

# Training of Election Administration International Events

Participation of BiH EMB members in:

- international events and
- trainings.

**Result:** increased overall capacity of election administration.

# Voter Education General Elections 2014

The objective of the educational campaign "How to vote" was to inform the voters about the levels of authority for which the 2014 General Elections are held and about the manner of correctly filling out the ballot.

Implementation: a month before the elections, ads published in high-circulation dailies.

# Voter Education General Elections 2014

The aim of **the campaign** was to encourage the voters to exercise their right to vote. The campaign was conducted on public and private electronic media, through TV clips and radio jingles, and billboards under the slogan of the BiH CEC for the 2014 General Elections **VOTE!**.

Video clips targeted:

- Youth
- Voters with disabilities
- None-voters

# Voter Education General Elections 2014

**Informing the voters via "SMS CENTER".** Every voter had the possibility to check location of its polling station by sending his/her Single identification number in a SMS message to 091 12 12 12. This was a single number for all mobile operators in BiH. The ad showing the number of the SMS center was broadcasted by all TV and radio stations.

**Website of the BiH CEC.** Aimed at timely dissemination of information to the voters the web page of the BiH Central Election Commission was continuously and timely updated. All information that were significant to the electoral process, decisions, press releases, statistics, by-laws and normative documents were made available to the public.

# Training of other electoral stakeholders

- Training of representatives of political subjects – potential presidents of polling station committees
- Training election observers, including training of trainers
- Training for international observers

# Conclusion

Continued education of election stakeholders is critically important!

Training of all election participants is our strategic commitment.

In support to our commitment, CEC is establishing own Center for Education. The Center is tasked to develop training curricula for electoral stakeholders.

The Center will be a hub for electoral education, with a physical capacity of training 120 people at a time, utilizing domestic and international experts.
